The objective of this Memorandum of Understanding is to establish a partnership bringing together:

Causedirect SA (Registration N° CHE-336.057.832), with its head office at Rue de Grenus 7, 1201 Geneva, Switzerland and represented by its founder and CEO, Patrick Vieljeux;

AND

Sierra Leone Ministry of Social Welfare (hereafter the “MOSW”) with its offices at New England Ville, Freetown, Sierra Leone West Africa, represented by its Deputy Minister Mohamed Haji Kella

AND

Community Action For Sustainable Development – Sierra Leone (hereafter “CASD-SL”) with its office 13 Amara Kanneh Street, Southern Region Bo, Sierra Leone, represented by Richmond Brima Kabbah, Founder and CEO,

TO CREATE

The **Community Consortium Sierra Leone** (hereafter CC-SL), in a partnership of non-profit organization working together to promote community safety for women and children in Sierra-leone. The consortium is supported and supervised through the Partnership Coordination Unit at the Ministry of Social Welfare and the lead leadership of CASD-SL to enhance sustainable transformation of rural communities in Sierra Leone.

Whereas Causedirect is a for purpose limited company incorporated under the laws and regulations of Switzerland, with a mandate to facilitate the funding and development of charitable organizations and sustainable projects around the world; to have a significant positive impact on society and the environment through its business and operational activities; to provide a solidarity engagement web platform that allows individuals and companies to select and donate to the organizations and projects they wish to support and/or to work as volunteers or mentors for these organizations; to promote and invest in non-profit organizations and sustainable projects, as well as to provide a impact and funding advisory service.

Article 1: OBJECTIVE AND SCOPE

The general purpose of this Memorandum of Understanding is to provide oversight to govern the relationship between the MOSW, Causdirect and partners, going forward.

Article 2: RESPONSIBILITIES

MOSW, Causedirect and CC-SL will set our pre-agreed-upon roles and responsibilities per project implemented over the duration of this partnership.

Article 3: THE MOSW, CAUSEDIRECT AND CASD-SL ACCEPT THE FOLLOWING

1. This MoU reflects the free and conscious will of who signed it, being assured that will promote ongoing mutual collaboration on and implementation of pre-identified projects.
2. All parties agree to partner on opportunities and a financial model will be agreed upon before each project/initiative is implemented.
3. In order to ensure the success of this partnership, the participants agree to strengthen trust and cooperation as well as facilitate continuous coordination and communication in order to achieve approved objectives.
4. All parties will respect each other's proprietary and confidential information, and follow upfront agreed-upon instruction on usage limitations.
5. All parties will respect each other's assets (including databases), and follow instruction on usage limitations and access.
6. The MoU is valid for the period of one year, starting from date of signature.
7. The parties can agree to terminate the MoU at any time.
